Terms & Conditions

- 1- The terms of the agreement/MOU will be for ten years
- 2- Minimum 90 days prior written notice to dissolution of the MOU (Either Organization)

- 3- ZMT Clinic Network (A Project of Zubaida Machiyara Trust) offered services to the all deserving Patients Free of Cost.
- 4- All the equipment, furniture and fixture will be provided by zmt and remains property of ZMT
- 5- All hiring will be though HR department of ZMT Clinic Network
- 6- ZMT Clinic Network offered services to the deserving patients Free of Cost.
- 7- All Utilities of the ZMT occupied building will be paid by Sindh Government Hospital Liaquatabad
- 8- The Property Ownership Registered Will Remain Same.
- 9- Anyone can visit the clinic, but no any visitor or member is allowed to interfere in ZMT Clinic administrative affairs.
- 10- The portion utilized by ZMT will be the responsibility to be maintained By ZMT Clinic Network
- 11- The major maintenance work of building will be responsibility of SGH.
- 12- All equipment of clinic will be maintained by ZMT Clinic Network
- 13- All IEC materials will be provided by,ZMT CLINIC NETWORK with the name written on sign boards, pamphlets, and flayers.
- 14- SGH will accomodate the patients in other supportive services like consultations, radiology, lab tests, and ipd etc referred from all ZMT CLINIC NETWORK particularly from physiotherapy center.
